ISSUE OF SECURITIES / SECTION 708A NOTICE

Silver Swan Group Limited's ability to pursue the aggressive exploration of its high-priority gold and base metal discoveries in the Meekatharra area of Western Australia, has been enhanced by the completion of a portion of the recent private share placement not subject to shareholder approval.

The placement, announced on 15 October 2008, raised a total of \$1,376,100 before costs from the issue of 3,058,000 fully paid ordinary shares each at an issue price of \$0.45.

Shareholder approval to complete the placement and issue a further 275,555 fully paid ordinary shares, each at an issue price of \$0.45, to a director and former director of the company has been sought in the Annual General Meeting Notice of Meeting.

The Annual General Meeting is scheduled to be held on the 27th November 2008.

The funds raised will be directed to increasing exploration activities over several high priority projects for gold, copper/gold and copper/zinc/lead/silver mineralization.


